COMMENTS FOR THE AUTHOR:

1. In the conclusion written that, "This study found more than half of the respondents to have performed their tarawih, Eid al-Fitr and five daily prayers at home. Respondents carried out various basic COVID-19 prevention behavioral measures during worship such as wearing masks, washing hands and maintaining a safe distance when worshipping."
The results of this study are interesting because if you read the research results done by Sukamto, and Parulian. "The response of the religious community to the Indonesian government's public policies regarding the Covid-19 pandemic." Journal of Law, Religion and State 8, no. 2-3 (2020): 273-283, responding to the Indonesian government's policy in dealing with the Covid-19 pandemic (Article 4 of Government Regulation (PP) No. 21/2020 mentions restrictions on religious activities), there was a small group of fanatic Muslims who initially opposed the policy especially in Bandung.
2. This article does not provide information on the response of the Muslim community (Muhammadiyah) based on region, city, or village. I think it necessary to be added, so could give horizons for the reader.
3. Based on the respondents' education, I think this research is more representative of the Muhammadiyah middle class. If I am right then the conclusion should be added that information.
4. This research, which was conducted from 18 to 25 July 2020, would be better added to the context of Indonesian society in general at that time in responding to government policies related to Covid-19.

Reviewer #3:

I am sure that this manuscript is successful to provide a valuable information about the congregational worshiping activities during the COVID-19 pandemic in Indonesia. However, considering all subjects of Indonesian Muslims in this study is coming from Muhammadiyah, the authors need to state this in the abstract.

Since the time within the pandemic situation may dynamically change the policies and public health measures that impacted congregational worshiping activities (e.g. wearing face mask was not quite suggested by the Indonesian authority during the early pandemic time - where it significantly changes in the next time until to date), it should be better to provide the study's time-frame in both title and abstract.

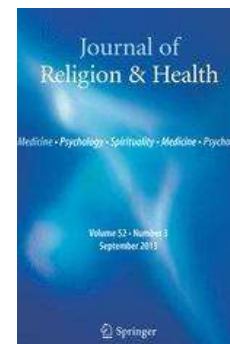
