#### ABSTRACT

Amelia Ayu Rosali. The Influence of HighScope Curriculum on English Language Learning of 5 – 6 years old children at Sekolah HighScope Indonesia, South Jakarta. Paper. Jakarta: Faculty of Teacher Training and Education, University of Muhammadiyah Prof. DR.HAMKA, 2019.

This study attempts to know whether is the influence rendering of English Language Learning of 5-6 years children at Sekolah HighSope Indonesia, South Jakarta. This research using quantitative methods. The study is done in Sekolah HighScope Indonesia, South Jakarta. This research population respondents, sample used were 63 respondents of five - six-year-old children. Sampling techniques used is saturated sample with quantitative using the survey by causal techniques. Distribution of data is normal and linear based on the linier norm<mark>al</mark>ity and test it, continued from the analysis variant (ANOVA). There is a correlation between the HighScope Curriculum variable and the English Language Learning variable becau<mark>se of the significance level above 0.05, which is 0.312, it means Ha</mark> accepted and Ho is rejected. In other words, there is an influence between the HighScope curriculum which can formulate English Language learning of 5-6 years children at HighScope Indonesia, Kuningan, South Jakarta. Based on the determinant coefficient with the formula  $KP = r^2 \times 100\% = 0.312^2 \times 100\% = 9.7$ %, means that the HighScope Curriculum variable contributes 9,7 % to English Language Learning of 5-6 years old children.

English is also important for Indonesian children based on research in Malaysia of 2017 by Suriati Sulaiman said participants viewed of mastering the English language among students. This in turn, will provide students with a stronger foundation of the language (Sulaiman, Sulaiman, & Rahim, 2017).

Lately the government has launched an international education ranging from basic education to higher education. In international standard schools is using English as a daily program. This matter conducted by the government as an effort to improve human resources who have reliability in

English. Ministry of Education Policy Number 0487/14/1992 Chapter VIII states that Elementary School can add subjects in its curriculum, provided the lesson is not contrary to the objectives of National Education. This policy was then followed up with the Decree of the Minister of Education and Culture No. 060 / U / 1993 dated February 25, 1993 on the possibility of an early English program as one of the local content subjects in elementary school. Children need to use a foreign language, especially English, therefore English is introduced from an early age, especially in Early Childhood Education institutions.

Language development is one of the main contributions in early childhood language development. By using language children might develop their competence better so it would go to social interacting with their peer, adult and environment.
