The rapid growth of online learning in higher education has been accelerated due to COVID-19 pandemic. This condition has led to developments in the area of e-assessment. This study examines postgraduates' experiences in e-assessment have heat backed not in Semi-structured interviews and a threaded discussion via WhatsApp's group were carried out after recruiting graduate students using a convenience sampling method. Thematic analysis was applied to the data. Findings revealed that the majority of students perfected offlier assessment to e-assessment for various reasons. Although students perceived the assessment to be useful, they expected more feedback and interactive communication with lecturers. The result also showed the low involvement of students in the assessment process. These findings present insights that may assist in enhancing the quality of e-assessment.




Current study


